The Seniority of Police Personnel in AP Bns from the cadre of Havildars onwards is decided by a variety of criteria. There are persons who are promoted from the cadre of Police Constable, persons appointed on Sports quota, Persons appointed through direct recruitment. As there were disputes among the above said groups drawing out a seniority list was very difficult. In addition, there were a plethora of litigations. As issue become very convoluted, Special teams were formed by PHQ to resolve the issue and a High Level Committee had issued suggestions for resolving the issue. In accordance with the directions of the High Level Committee and within the purview of judgements dtd 20.06.2005 in WA 462/02, WP (C).No.3695/2004, CCC No.1293/2000 and OP's No.22547/2000 and 4880/2001 and WP (C).No.36955/2004 of Hon'ble High Court, a revised combined Seniority List was published vide reference read as 3rd & 4th paper above. This list was challenged in the Hon'ble KAT by personnel belonging to Sports quota in OA No.1752 of 2012 and 7 other O.A's. In the common judgement dtd 16.09.2014 the Hon'ble KAT quashed the seniority lists referred as 3rd and 4th paper above. The State Police Chief vide Letter No.A3/56609/15 dtd 02.07.2015 directed to

prepare revised seniority list in conformity with the directions of the Hon'ble KAT in judgment dtd 16.09.2014.

Accordingly, the Provisional Seniority list of Havildars of AP Bns from 01.01.1984 to 31.12.11 is hereby published.

The Unit Heads concerned are directed to circulate this seniority list among the incumbents and complaints/objections if any may be collected from them and forward with specific remarks to the undersigned within 15 days. If no complaints/objections are received within the stipulated time, it will be presumed that no complaints/objections are there and the provisional modified seniority list of Havildars will be finalized accordingly. This Seniority List is purely provisional and subject to decision of the Hon'ble Court in the cases/appeals pending before the Hon'ble High Court. The list is also published in the official Website of the Kerala Police.
