**Order No : A5-4343/2010/TR Dated. 03-08-2015**

A revised Range wise seniority list of Reserve Sub Inspectors of Police in Thiruvananthapuram Range from 2002 onwards was published from this office vide order read as 1st paper above. On further verification, it is found that some anomalies are crept in the criteria adopted for the preparation of the year wise seniority lists published from this office from 2002 onwards, since 50% of the total vacancies are considered for the regularisation of Promotee & Direct RSIs each, instead of 50% of total sanctioned posts. Hence the Range wise seniority list of RSIs prepared from 2002 onwards requires modification for rectifying the anomalies found in this regard. For the same, the regularisation of provisional promotion of RASIs as RSIs are done based on the criteria of 50:50 ratio of posts to promotees and directly recruited RSIs.

In the above circumstances, provisional year wise revised seniority lists of RSIs of Thiruvananthapuram Range as on 01.04.2010 (01.01.2002 to 31.03.2010) is published as in the lists appended herewith. All unit heads of Tvpm Range are requested to circulate the provisional seniority list among all the concerned. Complaints/ Objections if any, in this regard may be forwarded to this office within 10 days from the date of publishing the list. If no complaints/objections are received within the stipulated period, it will be presumed that there is no objections against the seniority list and the provisional seniority list of RSIs will be finalised accordingly.

This office order read as 1st paper above in this regard is modified to this extent.
