**PROCEEDINGS OF THE DEPUTY INSPECTOR GENERAL OF POLICE,

Sub : Police Estt- Revised Provisional Seniority List of RSIs of Police in TvpM Range as on 01.04.2010 - Finalised- Orders issued.

A revised finalised Range wise seniority list of Reserve Sub Inspectors of Police in Thiruvananthapuram Range as on 01.01.2010 was published from this office vide order read as 2nd paper above. The same has to be modified as it is found that some anomalies are crept in the criteria adopted for the preparation of the year wise seniority lists published from this office from 2002 onwards, since 50% of the total vacancies are considered for the regularisation of Promotees & Direct RSIs respectively, instead of 50% of total sanctioned posts. Hence a revised provisional year wise seniority list of Reserve Sub Inspectors of Police in Thiruvananthapuram Range as on 01.04.2010 was published from this office vide this office order read as 1st paper above and circulated among all concerned calling for objections/complaints, if any. The regularisation of provisional promotion of RASIs as RSIs are done based on the criteria of 50:50 ratio of posts to promotees and directly recruited RSIs. Some complaints were received against the provisional seniority list as narrated below and all of them have been verified.

Sri.R Balan, RI of Police & Sri.K Ramachandran, RI of Police, Dist.AR, Kollam

Sri.R Balan, RI & Sri.K Ramachandran, RI have raised objection that they are eligible for regularization as RSI w.e.f 01.01.1991 and said that they are given regularisation only w.e.f 01.04.1995 in the provisional seniority list and requested action to allot correct regularisation and seniority to them. Both the petitions have been examined and found that, in compliance to the judgement dated 29.08.06 in OP No.5818/02 filed by Sri.K G Babu, the seniority position of Sri.R Balan & Sri.K Ramachandran in the category of RSI has already been re-fixed and the date of regularization of promotion in the cadre of RSI has been taken as 01.04.1995. In these circumstances, Sri.Balan & Sri.K Ramachandran, RIs of Police are given appropriate place & regularisation in the provisional seniority list and also in the finalised list.

Sri.P Sreekantan Nair, Sri.K Gopakumaran, Sri.T Sivanandan Nair, RSIs of Police, Dist.AR, TvpM City

The petitioners have lodged complaints before the State Police Chief, Kerala that they are not being included in the previous seniority list published vide this office Order No.A5/4343/2010 TR Dated 11/03/2015 and requested action to include them in the seniority list. The petitions have been examined and found that the provisional seniority list vide order No.A5/4343/2010 TR Dated 11/03/2015 was published by including incumbents upto Sri.Vijayakumar K, RSI and the provisional seniority list vide order No.A5/4343/2010 TR Dated 03/08/2015 was published by including incumbents upto Sri.Sahajan, RSI. Since the petitioners are eligible for seniority beyond them, they cannot be included in the list at present.

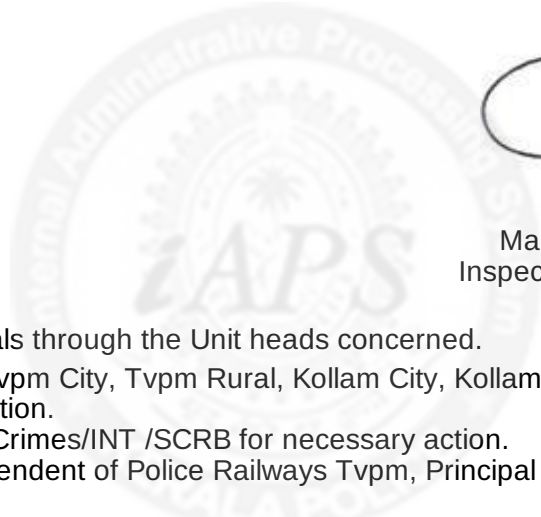
