As per the order read as 1st paper above a finalized seniority list of higher grade drivers as on 1/1/96 has been published and in these finalized seniority list of 328 higher grade drivers were included. Out of this, up to serial No. 234, Sri. Saludeen HC Driver 3859 were promoted as Driver SI and posted to Police Telecommunication HQ, vide DGO No. 1303/2015 dated 2/7/2015.

Meanwhile, Sri. M. Babu HC Driver 4020 of Kannur (Sl. No. 245) and Sri. Abdul Samad HC Driver 3388 of AR Alappuzha have submitted certain complaints against the above finalized seniority list. In this connection it is informed that they have not submitted any complaints while finalizing the seniority list. so the above two complaints have been examined in detail with relevant rules.

1. The complaint of Sri. Abdul Samad HC Driver 3388 is that his name has not been included in the finalized seniority list issued vide Order read as 1st paper above. On verifying the records it is seen that he has entered into service on 10/7/85 and 1st time bound higher grade was sanctioned to him on 10/7/1992. As such his seniority position will be in between Sri. Ponnappan HC DVR 3390 (Sl. No. 183) and Sri. Govindan HC DVR 3909 (Sl. No. 184). As such his request is correct. Hence he is placed as Sl. No. 183(a).

2. The complaint of Sri. Babu M. HC Driver 4020 is that his date of entry into service is noted as 22/3/1987 in the seniority list, instead of 22/9/86 and date of assigning of 7 years grade is noted as 27/3/94 instead of 22/9/93. On verifying the records it is seen that his claim is correct. Hence his seniority position will be in between Sri. Raveendran HC DVR 3449 (SL. No. 224) and Sri. Devassia HC DVR 388 (Sl. No. 225) . As such he is placed as Sl. No. 224(a). The serial No. 245 is hereby cancelled.

The finalized seniority list published vide the order read above stands modified to this extent.
