**ORDER NO/A1/10459/2015APB** **dated**

In pursuance of the common judgment dated 16/9/2015 of the Hon'ble KAT in OA No.1752 of 2012 and 7 other OAs, the finalized seniority list of Havildars of APBns published vide reference 4<sup>th</sup> and 5<sup>th</sup> above was necessitated to be revised. Accordingly the seniority list of Havildars of AP Bn wef 1-01-1984 to 31-12-2011 has been revised and the provisional combined seniority list of Havildars of APBn was published vide order read as 8<sup>th</sup> above and communicated to all concerned calling for objections ,if any against same giving a reasonable time.

2. Against the seniority list, a total No. of 86 representations have been received from the officers and Police Personnel whose names, objections raised in brief and the remarks on their petitions are furnished below:-
3. All the representations have been examined in detail with reference to the concerned records, relevant provisions of KS&SSRs, finalized seniority list of Havildars of each battalion. The requests that are found genuine and could be admitted as per the Rules and records have allowed and necessary corrections /modifications such as ranking, error in the date of enlistment, date of Promotion, date of Birth etc are accordingly made in the list

4. The petitions of Sri Muhammaed Reji, Hav 6253, (APSI, KSEB VIG), Anil Kumar P K, APSI, SBCID SEC (HAV 6242, SAP), A Noushad, HAV 6333, SAP (APASI, SAP)and Balamurali R APSI (BOI, TVPM , HAV 6295,SAP) , are that their names are not included in the provisional seniority list. The same has been examined with reference to the connected records and they are included in the combined seniority list of Havildars of AP Bn as on 31-12-2011.
  5. S/Sri Sakker Hussain, APSI SBCID (SEC, HAV 1658, KAP3), R Rajkumar, APSI, MSP, HAV 2042,KAP3, Joykutty Joseph, HAV 1774, (APSI, SBCID SEC), P M Abdul Razack. P M, APSI, KEPA,HAV 1249, KAP5, G Suresh, APSI, BOI, TVPM and K Rajan, APSI (HAV

2080) have requested to restore their seniority as ordered vide Order Number A1-3188/2003/APB Dated 11.05.2006. Necessary modifications have been made according to the APHQ order A1-3188/2003/APB Dated 11.05.2006.

6. Sarath Kumar R, HAV 7164, SAP requested to reassign his seniority by observing rule 12(a) and 28(a) of KS&SSR. The petition has been examined and found that he was promoted to the rank of Havildar as per BO No.250/00/S Dated 11-08-2000 and he is ranked in the seniority list according to the date of Order of Promotion as stipulated in Rule 27(a) of KS &SSRs.
7. P.Jayachandran, HAV 6367,SAP (APSI ,SAP) , Rajesh D, HAV 6425, Maheswaran, HAV 6460, requested to include his name in the combined seniority list of Havildars as on 31.12.2011.The matter has been examined and they are included according to the date of Order of Promotion as Havildar in the appropriate place.
8. M Noushad , APASI, SAP HAV 6386, and Rathnasamraj G, APASI, HAV 6391 have represented that their seniority in the rank of Havildar may be reckoned w.e.f 26-3-96 and 01.06.96 respectively vide Bo No 255/2015/S Dated 24.07.2015. As per BO Bo No 255/2015/S Dated 24.07.2015 they are included in the seniority list .
9. K Madhusoodhana Panicker, APSI, IRBN, K A Anson, APSI, SBCID, and Habeeb Rahman, APSI, MSP haave represented that they were appointed as per PHQ order No L1-161561/89 Dated 30.12.1989 –II and reported for training 21.05.1990 ,03.01.1990 respectively and requested to assign seniority w.e.f 30.12.1989.
10. It is further represented that Sri Ajith Kumar, Gopalakrishnapillai , S Sasidharan, Vijayakumar, Lambodharan, and Ayyappan (SI No 471,474,468,437,436,435, respectively in the provisional seniority list become Havildars only after the date of appointment of the petitioners and hence they have no claim for seniority over the petitioners who were appointed as Havildars vide Order Dated 30.12.1989.
11. S/Sri T K Ganesan APSI, KAP3Bn, G Muraleedharn Nair, APSI, KAP1 and P Unnikrishnan, APSI, BOI CIAL who were also appointed as per the above mentioned orders and reported for training on 17.11.1989 has represented with request to assign him seniority w.e.f 17.11.1985. in addition to that he submitted that the persons included in the seniority list of Havildars for the year 1988 as SI No 275,277,295 and 48 persons in the list for the year were wrongly placed above him as their promotion in the rank of Havildars were not according to the Rule 28(a) of KS &SSRs.
12. The petitions are of similar in nature and has been examined with reference to the connected records and found that the petitioners were appointed under sports quota as per PHQ L1-161561/89 Dated 30.12.1989-II, But formal Government Orders regarding the appointment of the petitioners along with other 32 Havilders and creation of 34 supernumerary posts of Havildars to accommodate them was issued on 23.04.1990 vide GO (MS) No 67/1990/Home Dated 23.04.1990. After that the appointment of 14 Havildars including the petitioners who were given appointment by PHQ vide order No PHQ L1-161561/89 Dated 30.12.1989-II was regularized with effect from the date of Government order. Ie 23.04.1990. All the Havildars who were appointed as per the GO (MS) No 67/1990/Home Dated 23.04.1990 are ranked in the seniority list of Havildars according to the order of preference

as in the Government Order. Hence the ranking of the petitioners in the seniority list of Havildars is correct.

13. As the promotions of Havildars mentioned by the petitioners in their representation was as per the provisions contained in the GO (MS) 142/1985/Home Dated 01.07.1985, their ranking in the respective years seniority list are correct as per Rule 27(a) of KS &SSRs.
14. Sri Vikraman, APSI, BOI, TVPM, B Sunil Dutt, APSI, KAP3 and Sri Suresh Babu A, ASPI, RRRF have represented in their petition that their seniority is to be revised according to the Government order issued vide GO (RT) 2557/2007/Home Dated 28.09.2007.
15. The petition has been examined with reference to the connected records. The GO (RT) 2557/2007/Home Dated 28.09.2007 is seen quashed by the High Court of Kerala in the Judgment Dated 04.11.2009 in WP© No 34903/2007 and 8077/2009. All the connected writ appeals in the matter pending before the Honorable High Court have been disposed off.
16. Shri Madanan Nair, APSI, KAP3Bn, (BOI TVPM) has submitted that he was appointed as PC in the year 1990, declared the period of probation in the cadre of PC on 30.05.1993 and promoted as Havildar in the year 1995. He has requested to include him in the seniority list of Havildar in continuation of those who entered in service in the year 1990 and promoted prior to the date of his promotion. It is also submitted that a stay order is in force issued by the Honorable High Court Of Kerala in WP(c) No 2760/2009 filed by him against Judgment in WP(c) 34903/2007 Dated 04.11.2009. The request can't be considered as seniority is to be reckoned w.e.f. the date of Order of Promotion as stipulated in Rule 27(a) of KS&SSRs. The WP(c) No 2760/2009 filed by him against Judgment in WP(c) 34903/2007 Dated 04.11.2009 has been disposed of Honorable High Court of Kerala on 29.09.2015.
17. Sri Mujeeb Rahman, HAV 7162, SAP (ADI Unit PTC), has represented to reckon his seniority considering his Date of Advice of Kerala Public Service Commission as Police Constable/ Dated of Completion of probation in the rank of PC/Date of Commencement of probation / Date of regularization of promotion as Havildars. The Seniority list of Havildars is prepared as per Rule 27(a) of KS&SSRs. Hence the request of the petitioner deserves no merit.
18. Sri Biju T, HAV 4232, TT5, KEPA and Pradeep Krishnan.J.C, ASPI, SAP has requested to include as "Still in Battalion" instead of "Transferred to District AR" against the names in the seniority list. Necessary corrections have been made in the seniority list.
19. Sri Babu Pradeep, APSI, KEPA, (HAV 3065/KAP2) represented that the date of enlistment and date of promotion in the Havildar seniority list are not correct. It has been verified with the connected records and found that the date of entry in to service is mentioned as 22/7/1993 and his regular promotion as Havildar was as per Bo No 351/1995/KAP2 Dated 14.12.1995. His ranking in the seniority list as per the date of order of promotion as stipulated in Rule 27(a) of KS&SSRs.
20. Sri K Sukumarapillai, API (RTD) has requested that his date of birth and the entry "transferred to District AR" be corrected as 03.06.1951 and "Still In Battalion". Necessary corrections have been made in the seniority list.
21. Sri Abhilash S S, HAV 2985, KAP3(KEPA TSR) has requested to correct his name in the seniority list as Abhilash S S instead of Abhilash K . It is also represented to examine the ranking of Sri Jyothikumar HAV 7235, SAP as to whether his promotion was ordered vide Bo No 250/200/S Dated 11.08.2000. HAV 5061 Sri Baby P P also requested to examine the ranking of Sri Jyothikumar HAV 7235, SAP. The matter has been examined and his name is corrected as Abhilash S S and the case of order number and date of promotion of Sri Jyothikumar, HAV 7235, SAP with reference to the records and his order number and date of

promotion has been corrected as Bo No 152/2004/S Dated 24.03.2004 his ranking in the seniority list is also corrected accordingly.

22. Sri K P Gopinadhan, HAV 7509, SAP (KEPA TSR) has submitted that he was removed from service for unauthorized absence and later reinstated vide order number A2/7461/2006/APB Dated 07.12.2006 and subsequently promoted as Havildar vide B O No 185/10/S Dated, 04-06-10 . He claimed that he was eligible for promotion as Havildar w.e.f the date of reinstatement as he was test qualified prior to his removal from service. The petitioner is ranked according to his date of order of promotion as furnished in the finalized seniority list of Havildars of SAP. He is not eligible for seniority in the rank of Havildar from any other date prior to the date of order of promotion.
23. Sri K M Sajeevan, API (IP, Marine Enforcement, Vypin ) B Harikuamarn Nair, API, PRS, PTC and Suresh Kumar K S, API, BDDS, SBCID HQ, have requested to assign seniority in the rank of Havildar w.e.f 06.12.1985 . They are ranked in the seniority list according to the date of order of promotion as stipulated in Rule 27(a).
24. Sri C Chandrakumar, APSI, Watch and Ward, KLA, has claimed that he is eligible for inclusion in the seniority list of Havildars for the year 1984 as SI No 44. The petition has been examined with reference to this office records and as per records he was promoted as Havildar on 01-10-1988 and ranked accordingly.
25. Sri R Vinayaraj, HAV 7368, SAP has requested to reassign his seniority w.e.f the date of regularization of promotion as Havildar or as per the PSC advice number instead of date of order of promotion. His is ranked in the seniority list according to the date of order of promotion based on his ranking in the finalized seniority list of Havildar of SAP.
26. Sri K Suseelan, APASI, RRRF, (HAV 3175/ KAP2) has submitted that his name is to be included as SI No 154 in the seniority list of Havildars for the year 1998. The matter has been examined with reference to the connected records of KAP2Bn and found that his seniority is assigned wef 18-09-1998 (ie. The date of B.O No. 471/98 KAP 2 in which his juniors promoted as Hav.) as per order No. A2(B)/2045/12 KAP 2 Bn dated 26-11-2012. Accordingly he is ranked in the combined seniority list of Havildars of APBN.
27. Sri Binu T S, HAV 9857, SAP who was promoted vide B O No 136/2012/S Dated 31.03.2012 has submitted that his name is not included in the combined seniority list of Havildars as on 31.12.2011. The petitioner is eligible for inclusion in the seniority list of Havildars for the year 2012 only.
28. Sri. O. S Anilkumar has represented that his seniority is to be assigned according to his date of advice by KPSC for his initial appointment as Police Constable. As no rules permitted to do so his request cannot be considered.
29. Shri.R. Santhosh Kumar, Havildar 8593 SAP has requested to re assign his seniority in the rank of Havildar as was granted vide BO.No.232/2012-s dated 16-5-2012.The petitioner was promoted as Havildar as per BO.247/09 S dated 12-10-2009 and his seniority is reckoned with effect from the date of order of promotion.
30. Shri. Muhammed Naseer, APSI, KAPI BN, Thrisur has requested to reckon his seniority in the rank of Havildar with effect from the date of order of contract appointment . Shri. Mohammud Nazeer was appointed as Trainee to the post of Havildar as PHQ order No.C-31849/82 dated 25-2-1984 on contract basis for a period of one year by invoking Rule 9 A (1) of KS&SSRs .As per rule Rule 9A(2) a person appointed under Rule 9A (1) shall not be regarded as a member of the service in which the post he is appointed is included and shall not be entitled by reason only of such appointment to any preferential claim to any other

appointment to that or any other service ,class or category. Hence his request deserves no merits.

31. Shri.Abdul Gafoor API,SBCID (Sec) has requested to restore his seniority in the rank of Havildar as per the orders issued in compliance of the judgment in WP( C )28406/2006 F dated 1-11-2006 and PHQ letter No.L1/9053/2007 dated 17/2/2007 and order No.A1/10385/2006 APB dated 28/2/2007.The matter has been examined with reference to the connected records and his seniority is reassigned as ordered in the order No.A1/10385/2006 APB dated 28/2/2007 issued in pursuance of the judgment of the Hon'ble High Court of Kerala in WP( C )28406/2006/F dated 1-11-2006 and orders contained issued in the PHQ letter No.L1/9053/2007 dated 17/2/2007.
32. Shri. Salu K Thomas has requested to correct his name in the list and to edit the entry in the remarks coloumn as "Still in BN". Necessary corrections have been made in the seniority list as per his request.
33. Shri.L.G.Gopa Kumar APSI (Hav 6306 SAP ,SBCID Sec has submitted that Shri.Aji Kumar Hav 6310 who is junior to him in the rank of Havildar is shown as senior to him .The anomaly has been rectified and the petitioner's ranking in the seniority list has been corrected.
34. Shri. Babu Sebastian Hav 8517SAP (SBCID) has submitted that the combined seniority list of Havildars , the Havildars 8526,8556,8565,8589,8473,8504,8569,8599,8825,8858 are shown as senior to him. The matter has been examined with reference to the Finalized Seniority List of Havildars of SAP as on 28.12.2012 published vide B O No 563/2012/S Dated 28.12.2012 and found that the petitioner is ranked in that seniority list as junior to the above mentioned Havildars.
35. E.V.Ravi,(Hav 3366),APASI,KAP 4 Bn has requested to correct his date of birth as 15-5-1967 and the entry in the remarks column as "Still in Bn" necessary corrections have been made in the seniority list.
36. V.Chandran, Hav 3800, KAP 4 and O M Mohanan, HAV 3707, KAP4 Bn , Dinesh T, HAV 3771, KAP4Bn who were promoted to the rank of Havildar vide BO No.57/2000 KAP4 dated 17-2-200 has requested to reckon their seniority in the rank of Havildar considering the date of advice of KPSC for appointment as PC and date of regularization of promotion as Havildar. The matter has been examined with reference to the connected records. The petitioner was promoted as Havildar vide BO No.57/2000 KAP4 dated 17-2-200 and accordingly his seniority in the rank of Havildar is reckoned wef the date of order of promotion as per Rule 27(a) of KS&SSRs
37. Bahulayan .A.D,Hav 8836,SAP has submitted that in the combined seniority list of Havildars , the Havildars 8858,9020 are shown as senior to him.The matter has been examined with reference to the Finalized Seniority List of Havildars of SAP as on 28.12.2012 published vide B O No 563/2012/S Dated 28.12.2012 and found that the petitioner is ranked in that seniority list as junior to the above mentioned Havildars.
38. Sri V R Murukesh, HAV 7359, SAP and Anil L G, HAV 7344, SAP have submitted that they were promoted as Havildar Vide B O No 258/2001/S Dated 14.08.2001 and regularized w.e.f 22.02.2001 and after that they were reverted as PC as per B O No 156/2002 Dated 06.07.2002. They were again promoted as Havildar as per B O No 13/2005/S Dated 07.01.2005. They have requested to assign seniority w.e.f his date of first promotion and the

subsequent regularization of that promotion. Their request can't be considered as per rules as they were regularly promoted as Havildar w.e.f 07.01.2005 only.

39. Sri A Jahangir, APSI, KAP2Bn has represented that the promotions ordered by the Commandant SAP during the years 1990-1993 were without considering the availability of regular vacancies and requested to examine the matter and rectify the anomalies in the promotion to the post of Havildars ordered in the year 1992 and 1993. The petition has to be examined by the commandant SAP. The petitioner is ranked in the seniority list of Havildars according to the Date of Order of Promotion.
40. Sri Udayakumar K, APSI, HAV 1571, KAP5 (BOI, TVPM ) has requested to correct his date of entry into service 02.01.1993 instead of 01.02.1993 and to assign seniority in the rank of Havildar by considering Date of Entry into Service as the criteria to fix seniority in the rank of Havildar those who are promoted on the same date. The matter has been examined and corrected his Date of Enlistment as 02.01.1993. Date of entry into service cannot be taken as criteria to fix the seniority in the promotion post as per rule 27(a).
41. Padmanabha Pillai, APSI, SBCID has requested to correct his Date of Enlistment as 01.01.1988 instead of 06.01.1989 and date of birth as 01.05.1962 instead of 05.01.1962. Necessary corrections have been made after verifying the connected records
42. Varghese Jesson, API,SAP has requested to re-assign his seniority w.e.f 06.12.1985, i.e., w.e.f the date on which the vacancy of Havildar said to have been existed in KAP3Bn. The Petition has been examined with reference to the connected records. The petitioner was promoted as Havildar on 19.04.1986 and he is ranked in the seniority list w.e.f the date of order of promotion as stipulated in Rule 27(a) of KS&SSR.
43. Sri B S Anilkumar, HAV 4685, SAP (API, Marine Enforcement) has requested to delete duplicate entry as Sl No 284 in the combined seniority list. The matter has been examined and rectified.
44. Sri Suresh Kumar S, HAV 7337, SAP has submitted that he was promoted as Havildar Vide B O No 258/2001/S Dated 14.08.2001 and regularized w.e.f 10.01.2001 and after that he was reverted as PC vide order dated 10.01.2003. He was again promoted as Havildar as per B O No 13/2005/S Dated 07.01.2005. He has requested to assign seniority w.e.f his date of first promotion and the subsequent regularization of that promotion. His request can't be considered as per rules, as he was given regular promotion as Havildar w.e.f 07.01.2005 only.
45. Sri Sreekumar M K , APASI, KAP3 has requested to correct his date of entry into service as 01.02.1993 instead of 11.02.1993 and date of promotion as 06.04.1997 instead of 06.10.1997 and also requested to assign seniority considering his date of entry into service. The matter has been examined and necessary correction has been made in the seniority list. His request to assign seniority considering his date of entry into service cannot be considered as any rules permits to do so.
46. Sri C Justin, APSI, RRRF has submitted that in the seniority list he is ranked below S/Sri Abdul Rasheed, HAV 6583, Vinod Kumar HAV 6581, Raju Mathew, HAV 6582, P O Roy, HAV 6584, K A Basheer, HAV 2737 who were appointed along with the petitioner vide GO (Ms) 168/1990/Home Dated 14.12.1990. It is requested to rank the petitioner senior to them as they are younger to him. The petitioner was appointed as Havildar as per GO (Ms) 168/1990/Home Dated 14.12.1990 along with 16 others. All those who appointed as Havildar as per the GO (Ms) 168/1990/Home Dated 14.12.1990 are ranked in the seniority list of Havildars according to the order of preference as in the Government Order. Hence the ranking of the petitioner in the seniority list of Havildars is correct



47. K Ramadasan, APSI, KAP1Bn has requested to correct his Date of Promotion as 07.01.1992 instead of 01.06.1992. Necessary corrections have been made after verifying the connected records.
48. Shaiju S, APSI, (HAV 4118, KAP1Bn), who was appointed as Havildar under sports quota as per GO (MS) No 179/1997 Home Dated 18.07.1997 has requested to include his name in the combined seniority list. The matter has been examined with reference to the connected records and included his name in the combined seniority list of Havildars for the year 1997.
49. Sri Bosco Joseph, APSI, KAP1Bn has represented that Havildars 5487 Sudheesh, 5515 Vijayakumar, 5522 Chandran B, 5432 Babu S are junior to him but they are ranked in the seniority list as senior. The matter has been examined with relevant records, the petitioner was directly recruited as Havildar under sports Quota and appointed against the supernumerary posts created as ordered in GO (MS) No 67/1990/Home Dated 23.04.90. His seniority is assigned as per the order of preference as shown in the Government order. The Havildars 5487 Sudheesh, 5515 Vijayakumar, 5522 Chandran B, 5432 Babu S are promoted to the rank of Havildar w.e.f 17/8/1989 and therefore they are senior to the petitioner.
50. Sri Benny Joseph, API, KEPA has requested to correct the date of enlistment as 05.03.1984 instead of 03.05.1984, further it is requested to reckon his period of contract appointment for seniority in the rank of Havildar, Sri M R Suresh Babu, API, KEPA also requested to reckon his period of contract appointment for seniority in the rank of Havildar. Necessary corrections have been made in the date of enlistment in the seniority list in respect of Sri Benny Joseph. The petitioner was appointed as Trainee to the post of Havildar as PHQ order No.C-31849/82 dated 25-2-1984 on contract basis for a period of one year by invoking Rule 9 A (1) of KS&SSRs .As per rule 9A(2) a person appointed under Rule 9A (1) shall not be regarded as a member of the service in which the post he is appointed is included and shall not be entitled by reason only of such appointment to any preferential claim to any other appointment to that or any other service ,class or category. Hence his request for seniority w.e.f the date of contract appointment is deserves no merits.
51. Smt Sini B Nair, HAV8473, SAP has represented that her name is to be included in the seniority list just below HAV 8472 Santhosh Kumar and requested to correct the position. The matter has been examined with reference to the Finalized Seniority List of Havildars of SAP as on 28.12.2012 published vide B O No 563/2012/S Dated 28.12.2012 and the petitioner is ranked as Sl. No 167 just below HAV 8582, Arun Chandran and just above HAV 8504, Sindle Kumar. Her ranking in the combined seniority list of Havildars is according to the order of preference as in the seniority list of Havildars of SAP.
52. Sri Sinilal R P, HAV 7004, KAP4Bn has requested to correct his initials as “R P” instead of “K P”. Necessary corrections have been made after verifying the connected records.
53. P Annan, APSI, KEPA, TSR has requested to include him in the seniority list according to the date of advice by KPSC as he was directly recruited as Havildar as per letter No. SR I (III)1050/1990 SW Dated 20.01.1994. Necessary corrections have been made after verifying the connected records.
54. Sri Renjith K, HAV 6567, KAP4Bn has represented that he was promoted as Havildar as per B O No 379/2010/KAP4Bn Dated 06.10.2010 and the Havildars of KAP5Bn who promoted as per B O No 229/2010/KAP5Bn Dated 15.10.2010 are ranked above him in the combined seniority list of Havildars and requested to rectify the anomaly. The matter has been examined with reference to connected records and the seniority of the petitioner has been re assigned according to his date of order of promotion.

55. Sri K C Kuriachan, APSI, KAP4Bn, has represented that he was initially appointed as Police Constable on 25.02.1984, Later Appointed as Havildar as per order No. Sports 31849/1982 Dated 29.06.1984 and he completed training on 04.12.1984. On verification of his order of appointment in the rank of PC, Havildar, and orders regarding the declaration completion of training, it is found that the petition matter is genuine Accordingly his ranking in the seniority list is reckoned w.e.f 04.12.1985 as the period of training and contract of one year expired on 03.12.1985.
56. Sri Hariprasad K, HAV 7856,SAP has submitted that he was promoted as Havildar Vide B O No 258/2001/S Dated 14.08.2001 and regularized w.e.f 06.02.2001 and after that he was reverted as PC as per B O No 107/2002 Dated 25.02.2002. he was again promoted as Havildar as per B O No 13/2005/S Dated 07.01.2005. He has requested to assign seniority w.e.f his date of first promotion and the subsequent regularization of that promotion. His request can't be considered as per rules as his regular promotion as Havildar is w.e.f 07.01.2005 only.
57. Sri Chandrababu C, API, SAP has requested to correct his date of entry into service as 07.02.1984 instead of 09.12.1984 and unit of appointment as KAP2 instead of MSP. Further requested to correct his date of promotion as Havildar as 18.10.1986 instead of 27.11.1986. His date of entry into service and unit of appointment has been corrected after verifying the connected records and found that date of order of promotion requires no change.
58. Sri.Ratheesh Kumar V R, HAV 9978, SAP, Kamal V Dev, HAV 10029, SAP, Rajeev R P, HAV 10299, SAP , Sri.Anvar A M, Hav 9301, SAP, Sri.Vinod Kumar S, HAV 8605, SAP, Sri.Yatheendra Nath M V , HAV 8661, Sri.R S Santhosh Kumar , HAV 9339, SAP , Sri.Surendran D, HAV 7144, SAP, Sri.Ajayaghosh R S, HAV 9757, SAP, Sri.Anesh V S, HAV 9962, SAP have submitted that their ranking in the combined seniority list differs from the ranking in the order of promotion issued by Commandant, SAP. The petitions have been examined with reference to the finalized seniority list of Havildars of SAP w.e.f 01.01.1998 to 31.12.2011 issued vide B O 563/2011/S Dated 28.12.2012 and they are ranked in the combined seniority list of Havildars of APBN according to the order of preference in the finalized seniority list of Havildars of SAP w.e.f 01.01.1998 to 31.12.2011 issued vide B O 563/2011/S Dated 28.12.2012. Therefore the petitions are to be examined by the Commandant, SAP.
59. Sri.R Varadarajan Pillai, APSI, SAP has submitted that the provisional seniority list does not contains the date of declaration of probation in the rank of PC and Date of regularization of Havildar promotion etc and to re-assign his seniority over the 1993 batch personnel who were promoted as Havildar during their period of probation in the rank of PC considering the date of entry into service of the petitioner and declaration of probation. The matter has been examined with reference to GO (MS) No.142/85/Home dated1/7/1985 and Rule 27(a) of KS&SSRs . Necessary provisions are included in the GO (MS) No.142/85/Home dated1/7/1985 to promote PCs before completing their period of probation. There for their promotion is in order and they are ranked in the seniority list as stipulated in Rule 27(a) of KS&SSRs
60. Sri Geo John, HAV 10936, who was appointed under sports quota, has requested to reassign his seniority according to the date of birth. Necessary corrections have been made after verifying the connected records.

61. Subject to the above condition and disposal of OA/WPs /WA pending before the Hon'ble courts, the provisional seniority list of Havildars of AP Bns wef 1-1-1984 to 31-12-2011 published vide order read as 8th paper above is finalized with the modifications to the extent of corrections made based on the representations mentioned above.
62. The finalized seniority list of Havildars of AP Bns wef 1-1-1984 to 31-12-2011 is finalized and published herewith for information of all concerned.

The seniority list published vide order read as 5<sup>th</sup> paper stands cancelled.
