As per the order read as 1st paper above a finalized seniority list of higher grade drivers as on 1/1/96 has been published and in these finalized seniority list of 328 higher grade drivers were included. Out of this, up to serial No. 242, Sri. K. V. Varghese HC Driver 197 was promoted as Driver SI and posted in Thiruvananthapuram Rural vide DGO No. 2594/2015 dated 17/12/2015.

Now, Sri. C. K. Satheesan HC Driver E 7039 of Ernakulam Rural complained that his name was not included in the finalized seniority list of higher grade drivers issued vide Order read as 1st paper above. On verifying the records it is seen that Sri. C. K. Satheesan HC Driver E 7039 entered into service on 25/3/1987 and 1st time bound higher grade was sanctioned to him on 25/3/1994. As such his seniority position will be in between Sri.K. A. Sadanandan HC DVR 192 ( Sl. No.243) and Sri.N. C. Viswanathan HC DVR 3476 ( Sl. No. 244). His request is genuine. Hence he is placed as Sl. No. 243(a) in between Sri.K. A. Sadanandan HC DVR 192 ( Sl. No.243) and Sri.N. C. Viswanathan HC DVR 3476 ( Sl. No. 244) in the finalised seniority list of higher grade drivers.

The finalized seniority list published vide the order read above stands modified to this extent.
