Sub : Police Estt- Revised provisional Range Seniority/Regularization lists of SIs(GE) in respect of Kannur Range for the period from 1996 to 2006 - Finalized-Orders Issued.

In pursuance of the direction of the State Police Chief, Kerala vide letter No.E2/24772/2014/PHQ dated 04/2016, seniority lists of Sub Inspectors of Police(GE) in respect of Kannur Range for the period from 1996 to 2006 has been provisionally revised and circulated among all the concerned inviting representations/errors etc if any within 7 days, vide reference 1st cited. For making wider publicity, the provisional list has been published in the official website of Kerala Police also. Only the representation of Sri Rajendran K, D 5511, Sub Inspector of Police, Bepore Police Station, Kozhikode City has been received in this office till 04.05.2016.

Sri Rajendran K, D 5511, Sub Inspector of Police, Bepore Police Station, Kozhikode City represented that he entered into service through special recruitment. He was promoted as Sub Inspector of Police as per SO No.221/02 dated 27.10.02 and his provisional promotion as SI (GE) was regularized with effect from 01.03.04. But in the revised provisional list his date of regularization has been changed as 01.05.04 and requested to correct the same as 01.03.04.

The regularization of provisional promotion of Sub Inspectors of Police(GE) as per revised criteria has already been done from 2000 onwards as per the directions from Police Headquarters vide E2/91359/07 dated 27.01.09 adopting 1:1 ratio (regularizing 50

% of the Sanctioned Strength on every year). Sri Rajendran K , D 5511 got regularized with effect from 01.03.04 in the seniority list which was published accordingly vide A1/14674/10 KR dated 30.01.11. But now the regularization has been done from 1996 onwards as per the direction from Police Headquarters since some shortcomings were noticed for the regularization of promotions given to SIs (GE) from 1996 onwards. Accordingly, promotions of promoted SIs have been re-regularized from 1996 to 2006 and the provisional list was published vide reference 1st cited. In the list Sri Rajendran K, D 5511, SI of Police got regularized with effect from 01.05.04. Representation of Sri Rajendran K , D 5511 has been verified with records and found that the date of regularization assigned to him in the provisional list is correct. Hence the representation is not considered.

No other representations have been received against the regularization list till date. Therefore the provisional list of re-regularization of promoted SIs(GE) for the period from 1996 to 2006 published vide reference 1st cited is hereby finalized. Finalized seniority list is appended herewith.
