Range Wise Seniority/Regularization lists of promotee SIs(GE) in respect of Kannur Range for the period from 1995 to 2003 was published as per the orders read as 3rd to 4th cited above. As per the guidelines issued in the order read as 2nd cited above, it was directed to recast the seniority/regularization lists from 2000 to 2003 since some shortcomings were noticed in the regularization of promotee SIs(GE) for the period from 2000 to 2003. Accordingly, seniority list of SIs(GE) in respect of Kannur Range published vide order read as 4th above was revised as per order vide 6th cited above, regularizing promotion of SIs(GE) against 50% of the sanctioned strength on each year from 2000 to 2003 including 41 posts of special units



allotted to this range from Police Headquarters vide E2/91359/07 dated 18.04.09 . Consequent to the above order vide 6th above, the regularization of promotion of SIs(GE) against 50% of the sanctioned strength for the period from 01.01.04 to 01.01.07 and 01.01.08 to 01.01.10 was also done as per the orders vide reference 7th and 8th cited above respectively.

The Statewide Combined seniority list of SIs(GE) is being prepared by the State Police Chief, Kerala by keeping 1:1 ratio (50 % posts of SIs(GE) are filled up by promotion and 50 % through direct recruitment). Accordingly, the Statewide seniority list of SIs(GE) for the year 2004, 2005 and 2006 have been finalized and published by the State Police Chief, Kerala as per E2/66255/10 dated 08.05.2015. Sri Vidyadharan, Inspector of Police (Directly recruited as SI), had submitted representation to the Hon'ble Minister for Home and Vigilance, Kerala raising objection regarding non maintenance of 1:1 ratio against the statewide seniority list of SI(GE). A committee headed by Sri Shefeen Ahamed K IPS, was constituted by the Hon'ble Minister for Home and Vigilance, Kerala to examine the issue and to furnish report. The committee submitted its report recommending to review the regularization date given to the promoted SIs for the period from 01.01.96 to 31.12.2006 and to prepare year wise seniority lists for the period from 1996 to 2006 based on the revised regularization and to avoid anomalies on regularization and future disputes on promotion.


On the basis of the findings and recommendations of the Committee, Government issued direction to the State Police Chief, Kerala vide letter No.80928/A2/2016/Home dated 04.04.2016 to revise the Statewide Combined Seniority list of SIs(GE) published as per E2/66255/10 dated 08.05.2015. In view of the Government direction vide letter No.80928/A2/2016/Home dated 04.04.2016, the State Police Chief, Kerala has issued direction to take immediate measures to revise the range wise seniority lists of SIs(GE) year



wise from 1996 to 2006 read as 1st cited above.

In pursuance of the direction of the State Police Chief, Kerala read as 1st above, the seniority list of promote Sub Inspectors of Police(GE) in respect of Kannur Range for the period from 1996 to 2006 is hereby provisionally revised in year wise manner from 1996 (as on 01.01.97) to 2006 (as on 01.07.07) regularizing 50% of the sanctioned strength to promote SIs(GE) every year. The 41 posts of special units allotted from Police Headquarters for regularization as per E2/91359/08 dated 30.01.09 are also taken into account for regularization. The seniority lists for the year from 1996 to 2006 is appended herewith. This office orders read as 3rd, 6th and 7th cited above are modified to this extend.

The District Police Chiefs/Superintendents of Police and the concerned officers will circulate the list among the concerned under proper acknowledgement. Omissions,Objections, Suggestions, errors etc if any received against the list should be reach to this office with specific remarks within 7 days. The belated representations will not be entertained and the list will be finalized accordingly.
