As per the PHQ letter read as 1st ,re-tenders were invited for the purchase of 12V 150 AH 21 plate at secondary batteries for the use of the police telecommunication unit and open the tender on 23/10/2014.Seven firms namely M/S Govind Auto Spares Pattom Tvpm,M/S tractors and Farm Equipment Ltd77,Nugambakkam Chennai ,M/S Subbiah Agencies, Killipalam ,Tvpm,M/S Sidco marketing cell,Tvpm,M/S scientific international,Poolakutty PO, kannur,M/S Celco Batteries Pvt Ltd ,Kodungallor Thrissur and M/S IGA tech Industrial electronics Pvt.Ltd Medical college P O, Tvpm were participated in the tender.Among them M/S Govind Auto Spares, Pattom ,Tvpm had quoted the lowest amount and it is decided to purchase 190 numbers of secondary batteries from them and seek administrative sanction from PHQ vide letter read as 2nd.The PHQ vide letter read as 3rd instructed to purchase 190 numbers of 12V 150 AH 21 plate at secondary batteries for the use of police telecommunication following all codal formalities.As such supply order has been issued to M/S Govind Auto Spares,Pattom,Tvpm with terms and conditions vide letter read as 4th by directing the firm that to execute an agreement in the prescribed form for one hundred rupees on kerala stamp paper and furnishing a security deposit of 5% of total cost with in a fortnight for the due fulfillment of the contract.But the firm M/S Govind Auto Spares,Pattom,Tvpm vide paper read as the 5th has informed that they are unable to pay 5% security deposit as they are suffering a loss as the prices of quoted batteries has gone up by 4%.The matter has been informed to PHQ vide letter read as 6th for considering the request of the firm . The PHQ vide letter read as 7th informed that necessary bank guarantee may be obtained from the firm for the purchase of 190 numbers of 12V 150 AH 21 plate at secondary batteries.As such the firm has been requested to submit necessary bank guarantee instead of 5 % security deposit on or before 03/12/2014 vide letter read as 8th .The firm vide letter read as 9th paper has informed that, due to financial constraint etc. ,they are not in a position financially to submit bank guarantee

In the above circumstances the supply order issued from this office vide read as 4th to M/S Govind Auto Spares,Pattom,Tvpm and the Re-Tender No.03/2014 are hereby canceled forthwith
