**02.Duties and Responsibilities:**

i) Police Airport Liaison Officers should ensure hustle free movements of Hon'ble Governor, Hon'ble Chief Minister, VIPs and Ministers by virtue of liaison with various agencies functioning at airport. Also ensure the police related works fall in the Airport with due care and courtesies.

ii) Two Officers will be available with duty and one officer will be at rest.

iii) They will perform duties both at International and Domestic Airport Terminals in 24 \*7 basis,working uniform with good turn out.

iv) They will be under supervision and control of DIG Headquarters and Day to day matters will be monitored by duty Officer,PHQ.

v) The Airport Liaison officers must ensures that good liaisoning with other agencies functioning at Airport.

03. The Unit Head concerned will relieve/admit the incumbent forthwith and report compliance. The Unit Head concerned will ensure that the relieved person reports back to the parent unit once his working arrangement is over. In the event of non compliance from the part of the personnel, it shall be the responsibility of the DPC/ Unit Head to ensure that no further disbursement of salary with respect to the personnel takes place from the Unit. The Unit Head concerned will make necessary entries in iAPS Nominal Roll, E-Roll and to report compliance by return.
